Municipal Government

Twenty-five years ago, the General Assembly enacted House Bill 489 and thereby created the periodic requirement that local governments adopt a "service delivery strategy." The stated intent of the legislature was "to provide a flexible framework within which local governments in each county can develop a service delivery system that is both efficient and responsive to citizens in their county." Over the subsequent decades, many disputes have arisen about the design and implementation of these strategies. Cities and counties often have very different perspectives when it comes to how best to provide efficient and responsive services to their residents. Speakers in this session will discuss the status of litigation between specific cities and their county counterparts, alternative forms of dispute resolution that might be considered, and the role of the Department of Community Affairs in supervising the process. Members of the General Assembly will share their perspective on service delivery.

Revenue and Finance

Room 204-206

Local Option Sales Tax, more commonly known as LOST, represents a vitally important revenue source for the cities of Georgia and is a crucial means of property tax reduction for residents. LOST is a one percent optional sales tax, levied county-wide in which the proceeds are split between the county and gualified municipalities according to a distribution agreement. Entering 2022, LOST was levied in 154 Georgia counties containing 484 gualified municipalities with over \$745 million collected in revenue. LOST proceeds on average represent 19 percent of municipal general fund revenue. As cities across Georgia have just experienced, LOST distribution certificates must be renegotiated following the decennial census, with failure to submit a new certificate by the end of last year resulting in LOST lapsing. Following this most recent round of LOST negotiations, attendees will hear from experts intimately involved in LOST renegotiation regarding experiences and difficulties, lessons learned, and potential future changes regarding this process.

Attendees will hear brief presentations about important new programs offered through GMA. Time will be allotted for Q&A following each program presentation.

The Cyber Aware Program is a security awareness training program powered by VC3. Ninety percent of all successful cyberattacks start in email, and cities can no longer rely on firewalls, antivirus software, and secure remote connections to protect them. Most cyberattacks are not sophisticated technical hacks. Instead, cyber attackers often use social engineering to trick people making the actions of staff one of the greatest risks to a city. This program educates and trains city officials and staff about cyberattacks and how to put measures in place to guard against them.

The Municipal Leader Diversity, Equity, and Inclusion Certificate Program consists of eight modules (Inclusive Leadership, Emotional Intelligence, Financial Management, Excellence in Public Safety, Economic and Community Growth, Community Engagement, Human Resources, Capstone Project) delivered monthly that provides city elected officials and senior staff with the knowledge, tools, and resources to create a foundation for sustainable, equitable, and economic prosperity for their city and its residents by creating an environment that values differences, fosters relationships and seeks a spirit of belongingness.

The Certified City of Diversity, Equity, Inclusion, and Belonging (Certified City of DEIB) Certification Program recognizes cities that adopt policies and practices that promote equity and inclusion within their municipal government and community in seven categories: Workforce Housing, Education, Health & Wellbeing, Public Safety & Restorative Justice, Community & Economic Development, Municipal Workforce Development & Employment, Community Dialogue/ Stakeholder Engagement. There are four tiers of certification available: Bronze, Silver, Gold and Platinum.



The Excellence in Policing Certification Program is designed to walk police agencies through the process of strengthening departmental policies and practices that meet standards in line with other certification programs and can be implemented in a cost-effective and efficient manner. It demonstrates a commitment to the highest professional standards, offers peace of mind for city leaders, and prioritizes equity and inclusion. The program consists of 12 required policy areas: Equal Opportunity Employment Plan, Officer Code of Conduct, Vehicle Operations and Pursuit, Evidence and Property, Search and Seizure, Use of Force/Response to Aggression, Arrest, Equipment Usage, Off-duty Employment, Crisis Incident Stress Management, Body and Car Cameras, Public Safety Information Officer. The program is a cooperative effort between the Georgia Municipal Association (GMA), Georgia Association of Chiefs of Police (GACP) and Local Government Risk Management Services (LGRMS).

The Embrace Civility Initiative encourages elected officials to nurture a civil environment. "Civility" refers to the ability to acknowledge the humanity of others, which is a necessary component of sociability. It enables us to live, work, and play in organizations and communities respectfully and kindly. By adopting the model Embrace Civility Pledge, the governing body demonstrates a commitment to fostering a social environment where everyone is treated civilly and respectfully.


Cities United Day at the Capitol
