GRANT CYCLE

- a. Define Project/Needs
- b. Research Opportunities
- c. Follow NOFO/RFP Instructions to the Letter
- d. Submit Proposal on Time
- e. Wait 3-10 Months
- f. When Funded: Complete All Objectives, Spend All the Money According to Your Approved Budget
- g. Lather, Rinse, Repeat

OPERATIONS: FINANCES

- Don't compete against yourself! Align finance, procurement, planning, and departments
- b. Overall and departmental budgets approved and organized
- c. Financial reporting monthly, quarterly, annually
- d. Budget for match (cannot be other federal funds)
- e. Program priorities / wishlist
- f. Registered in SAM.gov, grants.gov, login.gov, state, and federal agency portals





OPERATIONS: GRANT MANAGEMENT CAPACITY

BE FAMILIAR WITH:

- a. The Federal <u>2 CFR 200 Uniform</u> <u>Administrative Requirements, Cost Principles,</u> <u>and Audit Requirements</u>
- b. <u>Title VI</u>
- c. American with Disabilities Act
- d. Capital projects
 - a. Davis Bacon Act
 - b. Buy America
 - c. Both are especially important provisions that may have different standards than state or local wage or procurement requirements

FEDERAL/STATE GRANT READINESS BEFORE GRANT OPPORTUNITY IS ANNOUNCED, PART 1

- a. Ongoing review of grant opportunities (state agency websites, grants.gov, federal agency websites)
- b. Check out current and past grantees on agency's program page, where available
- c. Renew or complete SAM.gov, grants.gov, login.gov, and state and federal agency portals
- d. Assemble grants team (subject matter experts, writer, editor, post award manager, finance and program people where appropriate)



FEDERAL/STATE GRANT READINESS BEFORE CAPITAL (BIL, IRA) GRANTS ARE ANNOUNCED, PART 2

- a. Understand Justice40 tools and census tracts (BIL, IRA, and other major federal funding). Know your <u>Justice40 designated</u> <u>census tracts</u>, as many discretionary grant programs give additional consideration to projects that benefit J40 census tracts.
- b. Involve <u>small and disadvantaged business enterprises</u> in projects and applications.
- c. Plan and budget for "meaningful public involvement" DOT guide in handouts
- d. Prepare your Capital Project's Benefit-Cost Analysis DOT
