Georgia is home to a robust commercial recycling industry with facilities that accept old carpet, glass, plastic, paper/paperboard, aluminum and even ceiling tiles. As value has dropped dramatically for certain streams of recyclables, the cost of transportation is not being recouped, resulting in price increases. The problems don't end with recycling. Biosolids are being turned away by some landfills causing systems to have to transport sludge to distant locations. Though the economy of municipal waste is under pressure, solutions can be found. The committee will hear from Abbey Patterson with Pratt Industries with the commercial perspective. Michelle Wiseman, Director of the Waste Diversion and Outreach for the City of Atlanta, will discuss opportunities in diversion and reuse. Sarah Visser from the Georgia Environmental Protection Division will give a departmental update. The Chairs of the House and Senate committees on Natural Resources and the Environment, Representative Lynn Smith and Senator Tyler Harper, have both been invited to offer insights into the legislative session.

Revenue and Finance

The 2019 session saw several pieces of legislation with a significant impact on municipal revenues. While House Bill 61 positioned the State of Georgia to begin collecting sales tax from remote sellers in January of 2019, much of this revenue is still not being collected. Representative Brett Harrell introduced House Bill 276 to collect sales tax on platforms that serve as online marketplaces or facilitators of online sales. The bill would bring in an estimated \$90 million in local taxes. The legislation made it through the House but was unable to gain final passage in the 2019 session. Representative Harrell, who serves as the House Ways and Means Chair, will be on hand to discuss this key piece of legislation as well as other priorities of the committee. His Senate counterpart, Chair Chuck Hufstetler of the Senate Finance committee will share the perspectives and priorities of his committee. Finally, Chair Shaw Blackmon, who has authored multiple bills dealing with the Title Ad Valorem Tax (TAVT) will be on hand to discuss how the changes in the statute have impacted local governments.

The U.S. Congress is readying an attempt to reauthorize federal funding for the nation's transportation infrastructure. The 2020 session of the General Assembly will consider legislation carried over from the previous year, including transit legislation aimed at coordination outside of metro Atlanta, regulation of alternative transportation options such as ride share and micromobility/e-scooters. In the interim, a few legislators have discussed freight mobility within and throughout Georgia and the anticipated increase in truck traffic. Increasing truck weight limits is also being promoted by some legislators, and this idea and other legislation will be on the table for discussion. Presenters will discuss state transportation policy initiatives and ideas to prepare to meet future mobility needs.
